## A. Determination of Quorum

Mr. Galloway opened the meeting at 4:04 pm and determined that there was a quorum as all board members were present.

Mr. Galloway moved to amend the agenda to move item J., Executive Session, to the beginning of the meeting. Second by Mr. Ballard. Motion passed 5-0.

Ms. King had sent a proposal to Board about this topic ahead of the meeting. The proposal calls for the County to repair the road, if their Board of Commissioners approves, the Land Bank to pay for the improvements, and the residents to accept donation of the driveway after the improvements are completed. After discussion, Mr. Galloway stated that he would agree to the Land Bank transferring the property to the residents if the County will agree to one-time maintenance and upgrade of this driveway and the residents agree to accept dedication afterwards. Ms. King made that motion, second by Ms. Beckham. Motion passed 5-0.

Staff presented a formal bidding policy along with a list of 6 tree service companies. After review, Mr. Ballard moved to approve the policy, second by Ms. Beckham.
